Honorable Special District Members, the [Orange County Local Agency Formation Commission](#) (OC LAFCO, the Commission) held in-person meetings on [October 12](#), [November 9](#), [December 14](#), 2022, and [January 11, 2023](#). **OC LAFCO's next meeting is Wednesday, March 8, 2023**, at 8:15 a.m. (the Feb. meeting was canceled), in the County Administration North (CAN) First Floor Multipurpose Room 101, at 400 W. Civic Center Drive, Santa Ana, CA 92701 (note: new meeting room location).

- **Officers** – Commissioners Davert and Wagner were re-elected Chair and Vice Chair respectively.
- **Incoming Commissioners** – The City Selection Committee and County Board of Supervisors will soon announce their selection of Commissioners to fill vacancies and serve on OC LAFCO.
- **MSRs Schedule:**
  - **MSRs In Progress** – The following Orange County independent special district MSRs continue from 2022 for completion in 2023: Capistrano, Emerald, and Three Arch Bay Community Services Districts; Buena Park Library District; Midway Sanitary District; and El Toro, Moulton Niguel, Orange County, and South Coast Water Districts.
  - **Upcoming MSRs** – The following Orange County independent special district MSRs are scheduled for 2023-2024: Orange County Vector Control District; Silverado-Modjeska Parks and Recreation District; and East Orange County, Irvine Ranch, Santa Margarita, Serrano, and Trabuco Water Districts.
- **MSRs Survey** – To improve future MSRs, OC LAFCO staff provides a [five-question survey](#) to each agency, following its MSR, to garner feedback from agencies and assist the Commission in enhancing or maintaining MSR process components.
